Davisburg. Commencing at intersection of s. bank of Bow river with 5th meridian, thence e. along s. bank of river to its intersection with w. bank of High river at mouth of High river, thence s.w. along w. bank of High river to its intersection with line between t. 20 and 21, thence w. along line between t. 20 and 21 to its intersection with line between r. 28 and 29, w. 4th m., thence northerly along line between r. 28 and 29 to n.e. corner of s. 13, t. 21, r. 29, w. 4th m., thence w. along line between n. and s. halves of t. 21 to its intersection with 5th meridian, thence n. along 5th meridian to place of beginning.
